ii. To aid, establish, run and maintain Hospitals, Dispensaries, Nursing Home, Clinics, Sanitarium and/or other Institution and/or Bodies for rendering Medical Aid and Relief to persons.

iii. To support, organise, maintain and run Cultural, Social, Educational and other Institutions for the Diffusion of Knowledge and advancement of Ideas and Thoughts, Literature, Science and Research Work.

iv. To feed the poor and establish, maintain and support and/or grant aid to Dhamshalas, Orphanages and/or also Houses and/or to give aid in cash or kind to the poor, widows or Needy persons.

v. To establish support and maintain, and/or to grant aid to Institutions for uplift or Backward and Depressed Classes and people irrespective of Caste and Creed.

vi. To establish, support and maintain Gaushalas, Pinjrapoles, Water, Hut etc. and grant aid to such Institutions.

vii. To grant stipends, prizes and such other aid or remuneration to Artists, Literatures, Musicians and like persons with a view to advancement of National Cultural or Knowledge.

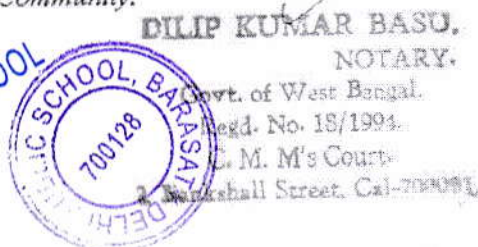
viii. To promote physical culture and education and to assist and promote support and Games and generally to do all acts for the improvements of Health and Physical Development of persons.

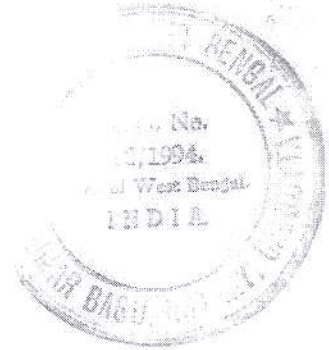
x. To give aid to persons and Institutions by way of loans and Advance and/or Otherwise with object of helping the poor and/or rehabilitating Displaced persons.

xiii. To promote, organise and administer and/or establish, support and maintain and/or grant aid to any person, Institution or Fund whatsoever, having for the object charitable purposes which tend to promote International welfare in which India is interested, provided, however, any expenditure outside India shall be with the general or special permission of the Central Board of Direct Taxes, Government of India, or any other "Statute or Lawful Authority" as may be required for taxation purpose.

6. The Trustees shall be at liberty in their absolute discretion to accept any property, contributions or Donations of Trust from any other persons, firm or company.

7. a) The Trustees in order to manage and administer the Trust conveniently and efficiently or for such other purpose as they shall think fit and proper, may appoint from amongst themselves two of the Trustees to be the Managing Trustees, to manage the Trust Estate and to carry out its objects and may delegate to the Managing Trustees, all or such necessary powers as are conferred on the Trustees under these presents.
